## Resumé

Neal A. Stone is a senior urban planner who has worked for nearly twenty years as a planning consultant, community development coordinator, project manager (PM), landscape designer, economic researcher, and field researcher in the Republic of the Philippines, the Canadian provinces of Saskatchewan and Manitoba, and the States of New York, New Jersey and Pennsylvania.
